#### **Problem Statement**

Public procurement is the worst vulnerable government activities to corruption (OECD, 2016).

Former Malaysia's Chief Auditor: "up to 30% of Malaysia's 2018 public projects, was lost due to mismanagement and corruption" (Satar, 2019)

SPRM reported 46.3% of the 4, 860 individuals detained since 2014 - 2019 were civil servant engage with procurement activities (Hussin, 2019).



- RO 1: To investigate factors influenced to the unethical behavior in public procurement.
- ➤ RO 2 : To identify which activities have the highest risk for unethical behavior in public procurement.


- Factors that influence to the unethical behavior in public procurement



Fraud Diamond Theory (Wolfe and Hermanson, 2004)



#### Conclusion

- Perceived pressure/ stimulus, opportunity, capability, collusion, time constraint, addiction and religious faith are factors influenced to unethical behaviour of public procurement
- These seven factors are found to be risky to occur during two (2) activities of the public procurement process; invitations to contractors and decision of procurement board
- Unethical behaviour of public procurement the entire management system may fail to deliver successfully and collapse the good governance of a country. Thus a huge effort needs to be done by all stakeholders namely
  - > SPA and JPA in recruiting and training/grooming ethical public servants;
  - ➤ MOF to identify loopholes in procurement procedures so as to not be taken advantage of by corrupt officers and contractors.
  - > Public service leaders should lead by example
  - > SPRM should put their effort to prevent more rather than mostly trying to cure or to apprehend.
